ITEM I CONFIRMATION OF MINUTES

ITEM II: DELEGATION - MR. AL GRIST, POCO HUNTING AND FISHING CLUB

Mr. Grist explained his club's current efforts at obtaining water for the hatchery located on the Coquitlam River. Since corresponding with the Committee in October, Mr. Grist had successfully obtained some guarantees of water from the G.V.R.D. and he felt this would be sufficient for the next two or three years until they get longer term plans finalized. They would like to obtain a deep well with direct feed to their hatchery to guarantee future continuous water supply. The Committee thanked Mr. Grist for his presentation and encouraged him to keep in touch with the Committee and Council on their very worth while project.

ITEM III: DELEGATION - MR. LEN CUDDFORD, POCO GARDEN CLUB

Mr. Cuddeford gave a brief history of his activity in the gardening club concept. It is the garden club's idea to make Port Coquitlam a "Garden City" where every house makes a display of their garden and landscaping. In addition they would like to sponsor a May Day float parade and anti-litter campaigns. Early recognition by Council of this worth while project would give a boost to the club's intentions. Alderman Keryluk suggested the staff research what is done in Calgary where roses and/or gardens are displayed on an annual basis. Mr. Cuddeford will be invited to a future Environmental Protection Meeting to discuss his proposals in more detail.

ITEM IV: PROCESSING AND MARKETING OF RECYCLABLES - AWARD OF CONTRACT

The Committee dealt with a report from the Deputy City Engineer recommending award of the Processing and Marketing of Commingled Recyclables Contract to E.T.L. - Environmental Technology Ltd. based in Richmond. The quoted price in E.T.L.'s proposal were:

For a period of eighteen months commencing February 1, 1991.

The committee considered all the information but requested clarification on Port Coquitlam's plan for including all materials in the recycling program. Committee felt an agenda which lays out full collection of all materials at the earliest possible date would be the best option to work towards. In addition, the Committee wishes to see a clear outline of estimated total cost per household per year for the full recycling plan once implemented. The Committee directed that the report be referred back to staff for further information and resubmission to the Committee prior to December 31, 1990.

ITEM V: PROCTOR AND GAMBLE - SOLID WASTE DISPOSAL

The Committee received and filed a copy of a newspaper article indicating that Proctor and Gamble's money was not accepted by the Capital Regional District to help design and build a composting plant for the region.

ITEM VI: STORM DRAIN MARKING PROGRAM

The Committee received a report from the Project Engineer indicating that the storm drain marking program sponsored by the Provincial Government was now being implemented in Port Coquitlam and the marking kits were available in the Engineering Department. So far the Girl Guides will use the kits as soon as weather permits.

ITEM VII: POWER SMART MONTH

The Committee received and filed the Mayor's letter and proclamation indicating the month of November to be power smart month in the City of Port Coquitlam.

ITEM IX: PERMANENT SIGNS FOR COQUITLAM RIVER FLOOD CONTROL PROJECT

The Committee considered a request from Environment Canada for the installation of signs along the Coquitlam River Flood Control Project (Dykes). Environment Canada submitted two designs for consideration. One design contained a pictorial map showing the dyked area and explaining the purpose of the fish habitat area. The other design had the same basic information but without the map. The committee recommends Council that they accept the design with the map and so advise Environment Canada.




