The report from the Parks Superintendent was discussed.



On Coast Meredian Road, at Lincoln, is on the east boulevard an old tall Balsam Fir .

This tree, a landmark has been there may be for some 200 years.

The east boulevard on Coast Meredian is quite wide, and north of the tree cars and truck can be parked (straight in) .

However, as Lincoln at the stopsign is a little bit down, and the tree is somewhat higher, than the surrounding, it has been suggested, that the tree should come down , as it could be a possible hazard.

If people were to follow proper proceedures at the stop sign, there is ample vision to the downcoming traffic from Coast Meredian, before one has to enter onto the intersection.

The 120 ft + tree's health is declining slowly, through road excavation, acid rain and other circumstances, but I feel strongly, that we could get lots of years of enjoyment from this old landmark, other than taking the short route, and cut it down hastily.
