Request to Waive Fees

W.S. Wingrove Memorial Slo-Pitch Tournament

#### Purpose/Problem:

The purpose of this report is to provide the Parks and Recreation Committee with information and a recommendation regarding a request received from the Port Coquitlam Fire Fighters Association to waive the fees relating to their annual slo-pitch tournament.

#### Recommendation:

It is recommended that the Parks and Recreation Committee deny the request to waive the "beer garden" fees and the fees related to using the concession trailer.

#### Background Information:

The Port Coquitlam Fire Fighters Association are holding their fourth annual W.S. Wingrove Memorial Slo-Pitch Tournament on the weekend of May 23-24, 1992. All proceeds from this tournament will be forwarded to the Burn Unit. Therefore the Fire Fighters have applied to have all fees waived so that they may lower their overhead costs and maximize their contribution to the Burn Unit.

#### Analysis:

We receive a number of requests to waive rental/service charges each year. With few exceptions, the Parks and Recreation Committee has consistently denied these requests. The rationale has been that we are trying to reduce our reliance on the tax base. If we waive the fees for fundraising events, which have the ability to generate funds, we will have a very difficult time dealing with requests from other organizations.

In the case of this request, the \$60.00 charged for moving the concession trailer only partially covers our actual costs. In the case of the \$156.00 "beer garden" fee, it helps with the extra costs (ie clean-up, etc.) that we incur as a result of beer gardens.

#### Summary:

The Port Coquitlam Fire Fighters Association have approached the City of Port Coquitlam to waive the "beer garden" fee and concession trailer service fee. They are hosting a Slo-Pitch Tournament at McLean Park on May 23-24, 1992. Proceeds from the tournament will be directed to the Burn Unit. Rental/service charges have normally not been waived for these types of events.
