The report from the Recreation Manager was reviewed.




That the Special Occasion License be approved and that these be taken to Council for adoption.


History/Background:

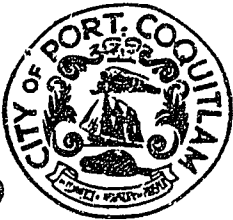
