



SUBJECT: Medal Recipients - B.C. Seniors Summer Games

Recommendation:

It is recommended that the individuals listed on the attached page be recognized by City Council for their success at the 1988 Seniors Summer Games.

Purpose/Problem:

The purpose of this report is to provide information to the Parks & Recreation Committee regarding the success enjoyed by some of our local seniors at the 1988 B.C. Senior Summer Games.

History/Background:

The first ever B.C. Senior Summer Games were held in Vernon on June 14, 15, & 16, 1988. Zone 3, (which includes Port Coquitlam residents), finished second overall in the competition behind Zone #5 (Vernon) and ahead of Zone #1 (Victoria) and the remaining zones.

Discussion/Justification:

Several of our local seniors placed in the top three in their event (list attached). It appears that it would be appropriate for City Council to recognize the endeavors of our local seniors.

Summary/Conclusion:

The first ever B.C. Senior Summer Games were held in Vernon in June. Zone 3 (which includes Port Coquitlam) finished second overall in the competition. Several local seniors finished in the top three in their specific events.

SUBJECT: Coquitlam Area Fine Arts Council -
Request To Waive Facility Rental Fee

Recommendation

It is recommended that the Parks & Recreation Committee deny the request received from the Coquitlam Area Fine Arts Council.

Purpose/Problems

The purpose of this report is to review the Coquitlam Area Fine Arts Council's request for free use of the Hyde Creek Auditorium (request attached) and to prepare a recommendation for the consideration of the Parks & Recreation Committee.

History/Background

The Coquitlam Area Fine Arts Council has booked the Hyde Creek Auditorium on Sunday, October 23rd, 1988, from 4:00 to 9:30 p.m. for a performance of "Fools Theatre". As is the case with many community events of this nature, their operating budget is minimal. Therefore, they have requested that the applicable facility rental fees be waived. "Fools Theatre" is a theatrical presentation put on by two actors and their dog. The one hour performance may include mime, juggling, magic, dancing, fire-eating, etc. Tickets are \$5.00 each. After the show, participants will have the opportunity to meet the artists. The Coquitlam Area Fine Arts Council is also working with the private sector to "mount the production".

Alternatives

There are four basic alternatives available for consideration:

1. We can approve Coquitlam Area Fine Arts Council's request for free use.
2. We can refuse Coquitlam Area Fine Arts Council's request for free use.
3. We can suggest some alternatives. such as a reduced rental fee.
4. We can approve the Coquitlam Area Fine Arts Council's request for free use of the Hyde Creek Auditorium but forewarn them that this is not an ongoing annual commitment.

Discussion/Justification

In an effort to decrease the reliance on the tax base, the Parks & Recreation Committee has been changing its practice with regard to free use of facilities. Waiving the rental fee for this event would result in a possible loss of revenue of approximately \$190. In addition, we would be absorbing all costs related to operating and cleaning this facility.

Summary/Conclusion

The Coquitlam Area Fine Arts Council has booked the Hyde Creek Auditorium on October 23rd, 1988, for a performance of "Fools Theatre". In an effort to keep their costs to a minimum, the Coquitlam Area Fine Arts Council has asked that all rental fees be waived. Approval of this request would result in a loss of revenues of approximately \$190.


The Parks & Recreation Committee has been working towards limiting the number of "free uses" being awarded.

A number of programs are now being offered at the Wilson Centre as a result of the new kitchen facility. These programs include a coffee service, baking program and lunch program.


Alternatives:

Discussion/Justification:


