### Re: Development in 3400 Block Ulster Street

Please accept our apologies for the delay in responding to your letter of March 25, 1988. In view of the fact that your letter has raised several concerns involving various departments of the City as well as the School Board it has taken us some time to come up with an adequate response to your letter.

Your letter raises three specific points which I will attempt to address.

Firstly, your observation that the north end of the 3400 block Ulster does not have curbs on the east side is correct. We find this configuration to be as unsatisfactory as you do. Unfortunately recent amendments to the Municipal Act limit the extent to which the City may demand certain off-site works to be completed by developers. Technically speaking the developer is under no obligations to construct more than half of Ulster Street. While all of us would certainly like to see the east side of Ulster properly curbed and the boulevards landscaped the shortage of Public Works Funds precludes this possibility.

Secondly, following your suggestion of effecting liaison between the School Board and the City, I have recently discussed this matter with Mr. Carson of the School Board. He has agreed to look into the possibility of erecting some concrete no-post guardrails to prevent traffic from negotiating around the wooden barricades at the north end of Ulster Street. As well, he has agreed to investigate into improving the appearance of the School Board property adjacent to the Lacrosse Box.

SUBJECT: Sports Aid Society - Request for Temporary Project Space

#### Recommendation

It is recommended that in recognition of their unusual circumstances, the Sports Aid Society be given "free" access to a Terry Fox Library meeting room over the summer months for use as a research office with the following considerations:

- Use of the room(s) must be flexible and allow for other users' schedules.
- \* The room must be cleaned up at the end of each work day.
- No furniture, equipment, or wall hangings will be stored in the roc1.
- \* Approval of this request does not in any way imply approval of future similar requests.

### Purpose/Problem

The purpose of this report is to provide information and a recommendation for the Parks & Recreation Committee's consideration regarding a request received from the Sports Aid Society for assistance in finding temporary office space for their summer research project.

### History/Background

As you can see from the attached letter, the Sports Aid Society has hired six students on a Challenge '88 grant to research "notable Canadians from Port Coquitlam, Coquitlam and Port Moody areas". The project runs from June 27th, 1988, to September 3rd, 1988. The group had arranged "free" space in the basement of a private home, but due to illness, have had to terminate these tive (Westwood Mall, vacant firehalls in Coquitlam, etc.) without success. As a last resort, they have approached us and requested that we consider loaning them space in one of our facilities.

### <u>Alternatives</u>

There are several alternatives available for consideration:

- 1. Deny the request received from the Sports Aid Society.
- 2. Approve the request and permit them to use the rooms (when available) located in the Terry Fox Library.
- 3. Approve the request and permit them to use the rooms (Young Room and Mabbett Room) located in the PoCo Recreation Centre when available.

## Discussion/Justification

Although this request would normally be denied, it is worthy of consideration in this instance because the group has made every effort to be self-sufficient and only came to us as a result of a turn of events which they had no control over. The times they are requesting are not prime times and would not normally be completely flexible; they do not need desks or a telephone and they would clean up each evening. The Terry Fox Library rooms at the library.

If we are not able to help them, they may have to cancel the project and six area students may lose work.

### Summary/Conclusion

The Sports Aid Society has contacted our office requesting office space for six local summer "Challenge 88" students. They approached our department because the office space they had arranged for themselves "fell through" in the last week or so. Since that time they have made every effort to find space on their own. If we are able to assist them, they are prepared to be flexible around our schedules, do not need desks or telephones and will clean up each evening.
