A meeting of the Parks & Recreation Committee was held in the Council Chambers on Tuesday, February 24th, 1987, at 4:45 p.m.

In attendance were Alderman George Laking and Alderman Mike Gates.

Also in attendance were K. Janna Taylor, Parks & Recreation Director; Deddi & Bill West & Kevin Smith (Item No. 1); Frank Kamiya, Architect (Item No. 2).

CONFIRMATION OF MINUTES

That the minutes of the meeting of the Parks & Recreation Committee held on Tuesday, February 17th, 1987, be taken as read and adopted.

Item No. 1


Citadel Heights

Deddi and Bill West from 1171 Castle Crescent and Kevin Smith of Genstar discussed the oak trees planted on the "island" in front of the West's home. The following concerns were brought up by Deddi and Bill West.

- a) Oak trees would grow too tall and would block their view.
- b) Indicated that other residents did not like the oak trees.
- c) When they bought, the island had not been planted and they had bought the lot for the view.
- d) Concern that the roots would eventually break the pavement.

Kevin Smith made the following points:

- a) All the islands are planted with similar vegetation.
- b) He has the fear that if we remove the oak trees on this island, we may be faced with removing others due to the fact that residents feel it blocks their views.

- c) Pointed out that if the owners in front of the West's wished to plant a tall tree, that they could not stop this happening.

It was pointed out to the Wests that the City of Port Coquitlam had indeed approved the plant material for the "islands" throughout the development.

Recommendation:

That the Parks & Recreation Committee will go out and look at the situation and get a report from the Parks Superintendent as to the eventual height of the trees and then take a recommendation to Council.

Item No. 2

Shimuza Sawmill


Frank Kamiya came to Committee to discuss the diversion of the PoCo Trail around the proposed sawmill. The owners are proposing a loop road around the actual sawmill. The road would have to be built up to a certain height similar to the dyke. Mr. Kamiya indicated that the City would have keys to the gate for access to the dyke where the present PoCo Trail is. He indicated that the sawmill will have a crane that will lift the logs across the dyke into the sawmill. Engineering is requiring the proposed loop road to be 6 metres and the Parks & Recreation Committee feels that this is too wide; however, the City Engineer will be invited to attend the next Committee meeting to discuss this matter. Concern regarding maintenance of both roads discussed.

Recommendation:

That the Committee agrees in principle to the proposed loop road around the sawmill.

Subject : Civic Awards

Policy: That the criteria for awarding City of Port Coquitlam Civic Awards as submitted with a memorandum from the City Clerk, November 22nd, 1974, be accepted.

- General:
1. The recipient must be or must have been a resident of Port Coquitlam for at least six months prior to the nomination for the award.
 2. No person or group of persons shall receive the award more than once for each specific award class
 3. Any person may nominate an individual or group of individuals by completing a nomination form, returning it to the City Clerk who will present it to the Council.
 4. A majority vote of Council is required to authorize presentation of an award except for "Recognition" when approval of the Mayor will suffice.
 5. An award or awards will not necessarily be awarded each year.
- A. Sports: May be awarded to an individual or team who places first, second or third at the highest Provincial level or for equivalent achievement.
 - B. Arts & Sciences: May be awarded to an individual or group of individuals who achieves the highest Provincial level or equivalent recognition for a work of art, performance, composition, scientific achievement or similar work.
 - C. Community Service: May be awarded to an individual or group of individuals who performs an outstanding service to the City, the Province, or Canada, or who, over a period of years served the City, the Province, or Canada in an outstanding manner.
 - D. Heroism: May be awarded to an individual or group of individuals who show outstanding heroism in the protection of life and/or property.
 - E. Recognition: May be awarded to recognize Wedding Anniversaries, Birthdays, or other personal milestones reached by City residents; or, if applicable, by clubs or organizations.
