## <u>Teen Dances</u>

The following report was given to the Parks & Recreation Committee by Janna:

- 2 -

I have discussed the aspect of teen dances with both Darlene Grieve and Joanne Edey Nicoll. As you are aware, both of these staff have, in the past, been responsible for the running of teen dances for the Parks & Recreation Department. It is agreed that there is definitely a need for teen dances in Port Coquitlam; presently there is not much available for teenagers in Port Coquitlam. It is not appropriate to have teen dances sponsored by individuals at this time.

If we are to seriously address this problem of providing good activities for our youth, we need to hire a youth worker. Other Parks & Recreation Departments, such as Maple Ridge and Surrey, have been seriously addressing the area of youth over the past years. We can choose to ignore our youth and do nothing or we can take a positive step forward and put money aside in next year's budget.

Recommendations (From Janna Taylor)

- 1. That we put monies in the 1986 provisional budget to hire a youth worker.
- 2. That the sponsoring of teen dances be by the Parks & Recreation Department and that these be instituted in 1987 (maximum four).

Much discussion took place with regard to the report. Committee felt that recognized community organizations should be permitted to host a teen dance. As to the aspect of a teen worker, the Committee had some reservations; however, they were prepared to support the concept that this be included in the provisional budget. With regard to teen dances, the Committee did support the proposal to sponsor two or three by the department in 1987.

- 3. Trim the branches on the trees close to the lamp by the playground equipment.

4. Dig out the stump.

Janna will get costings in regard to the removal of the hedge and the installation of another light.

## Dear Mr. Heffer;

In consideration of Port Coquitlam Arena purchasing only the soft drink products of C.C. Bottling Co. Consolidated Ltd., we will loan one (1) Scoretec 770 Hockey Scoreboard complete with Coca-Cola advertising to Port Coquitlam Arena for a period of six (6) years.



RE: Industrial Directory Signs

In reviewing potential locations for the Mary Hill Industrial Signs, the best location for the west Kingsway entry was found to be beside the Recreation Centre. Other locations considered were beside the City Yards and further north beside the B.C. Hydro Substation. The second two locations were discarded because of visibility problems, tenure in the case of the Court House site and access for burglars in the case of the Works Yard site.
