Dear Committee Hembers;

This is not a request or a complaint. It is a concern.

We are a registered non-profit society organized by volunteers to offer children's programs in our city. We are presently organizing our summer out-of-school program, for its sixth year. Because we spend time at the city pool and at beaches, we would like our children to be drownproofed. In the past, we've been refused group lessons so each parent has signed his/her child/ren up for swimming lessons and our group has spent their mornings around the pool, waiting for each member to finish a lesson.

Our request is for several group lessons solely for these kids. These are children of working parents, they are with us ten hours a day, Monday to Friday, so we can be quite flexible about time.

We phoned Janna Taylor at the beginning of April, she wouldn't discuss it, directing us to Darlene Grieve, who was on a lengthy vacation. Lee made a suggestion but needed Darlene's approval. We phoned on May 12 and Lee returned our call on May 14 saying Darlene refused.

We contacted the appropriate supervisors in Coquitlam and Port Mondy and have made satisfactory arrangements.

Wondering how we were going to explain this to our parents group, we contacted Michael Wright who directed us to phone Brian Kirk. He said Janna would phone me. Darlene Grieve phoned me, explaining that she couldn't do it because of budgeting, staffing, and availability of pool time. She did not want to set a precedent because she receives meny requests from preschools, daycares, and group homes.

I think you should be aware that thirty-six Port Coquitlam families will be attending swimming lessons in another municipality.
