CONFIRMATION OF MINUTES

Item No. 1      Marble under Statue at Terry Fox Library

The Committee discussed the attached memorandum from the Parks Superintendent and did not agree that we should etch the polished marble. Other alternatives will be investigated.

Item No. 2      Performing Rights Organization of Canada

It was brought to the attention of the Committee that the Performing Rights Organization of Canada Limited is permitted to collect fees under a tariff for music that is played in our facilities whether there is a dance or not. In the past, the Parks & Recreation Department has paid a licence fee for music performed during public skating sessions. There was much discussion by committee members on this particular item.

Item No. 3

Expo Logo

Janna went over the proposed location for the Expo logo, one being on the one side of Shaughnessy Street, by the Kentucky Chicken, and the other by the Chevron Station. One will say "Welcome Expo '86" and the other side will say "Port Coquitlam". The Parks Department is presently in the design stages for this particular flower bed and it is intended that the flower bed will be planted with colourful flowers of that particular season. The supplies and labour will amount to \$2,500. It was suggested also that this particular flower bed will be kept until 1988 and would be most suitable for Port Coquitlam's 75th birthday. The details of the competition are attached.

Recommendation:

That the City of Port Coquitlam enter the Expo Logo Contest sponsored by the Greater Vancouver Regional District.

Maintenance of School All-Weather Field


Recommendation:



Dear Mayor Traboulay:

At its September meeting the Greater Vancouver Regional District Board of Directors unanimously approved a motion that member municipalities participate in a floral or garden display in 1986, to celebrate and promote Expo.

A committee composed of Mr. Jim Slater, Deputy Parks Superintendent, North Vancouver District; Mr. Ted Rathony-Reusz, Parks Director, Port Moody; Mr. Dave Mitchell, Registrar, B. C. Society of Landscape Architects and myself met recently to consider guidelines for the competition. The principal recommendation was that they be as flexible as possible.

These are the guidelines:

- The competition is among municipalities, the theme is Expo.
- There are two categories:
  1. pedestrian - displays designed for viewing by pedestrians. They may be located at the municipal hall or in a public park.
  2. vehicular - displays designed for viewing by vehicular traffic. Logical locations would be on major streets, at entrances to the municipality.
- Displays may be of a temporary or permanent nature.
- There is no regulation as to the actual size or extent of the display, but the size and resources of the municipality will be a consideration in judging.
- Municipalities may enter projects they were planning for 1986, whether or not this competition was held. However, it is hoped the competition will encourage them to do something special to promote the Expo spirit.
- One entry per municipality.
- The display should be in place for the duration of Expo, though it may be changed from time to time.
- Displays should be in place on May 2, 1986, opening day for Expo.

A panel of judges will be appointed to adjudicate the entries and a trophy or other suitable prize awarded to the winner and runner-up.

The judges will visit the displays on several occasions. Winners will likely be announced in August.

We are hoping that all municipalities in Greater Vancouver will participate in this event. It is an opportunity to provide a colorful attraction in our communities and at the same time promote Expo.

We would appreciate knowing as soon as possible if your municipality plans to participate in the event.



In reply to your letter d.d November 21, 1985 I would propose that with the approval of our committee we approach the Schoolboard for their agreement that we obtain maintenance rights to the allweather field at Central school , including cost sharing funds as worked out per agreement.


With this field which supposed to be a bare all weather field , we like to experiment, that is : Overseed and fertilize, keep it cut as other fields, so if it has to be used in fall, weeds are not knee high. This is the main propleem with the fields of the schoolboard: no money to drag them, no money to cut the weeds etc.

If we could have this field for a number of years we could propably prove that with proper maintenance a field badly overgrown does not have to be a burden but rather a pleasure to own and play on

Also I would like to bring it to your attention again that upkeep on schoolfields have risen beyond the cost we recouperate from the board ,which cut us out of another few thousands dollars in 1985.


On behalf of the Port Coquitlam Minor Soccer Club we would like to make a request regarding upgrading of the all weather fields.

Hoping that you can accomodate us, I remain,

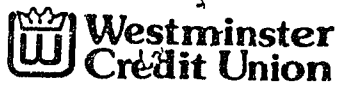

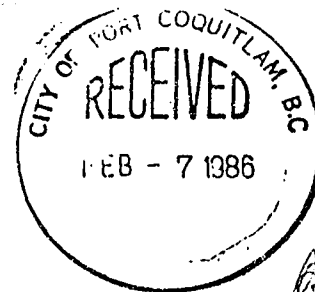
