#### HEALTH COMMITTED.

The Health Committee met on Monday the 22nd February 1926, at 2 p. m.

Present: - Ald Garbutt (Chairman), Ilmond, Bennett, Dean, Gibbens, MacInnis, Worthington and Woodside, and His Worship the Mayor (Ex-officio).

The minutes of the previous meeting were adorted.

The Committee begs to recommend to the City Council the adoption of the following report:-

# 1. Re Toilet for Workmen on Buildings.

Recommended that with reference to the letter received from the Vancouver Shinglers' Union re the above matter, a by-law be prepared requiring contractors to provide conveniences for the workmen engaged in the erection of buildings, and that the Chairman give notice of such by-law at the next meeting of the City Council.

# 2. Re City Analyst - Work for private parties.

A letter was received from Mr. C. N. Frey asking that permission be given the City nalyst to examine samples of mineral water for commercial purposes.

Recommended that the City Analyst be authorized to refuse if necessary to undertake any analytical work for private parties or for commercial purposes other than in the proper performance of his duties as City and Provincial Analyst.

# 3. Re Chinese Gardens, Block 9, D. L. 301

The special committee appointed re the above property reported as follows:-

"Re Block 9, we are of the opinion that the Gardens are not a nuisance, but certain buildings on the said property and occupied as dwellings and also as stable are very unsightly and must be unsanitary and do not conform to the standard required by the City Health Department and City Building Department, and therefore should be condemned as unfit for habitation and removed.
