No attempt has been made to search the files of the Laboratory but the above record is sufficient to show that for twenty years I have been doing the work of a Dominion Analyst, and that the results of my analyses have been accepted by the different Courts and by the Departments of the Government of Canada.

In again asking that I be appointed a Dominion Analyst, I would remind you that all correspondence in connection with this matter was handed to Dr. Clark, Assistant Deputy Minister of Health, in Ottawa on July, 1926.

The matter of my appointment as a Dominion Analyst has been discussed each year by the City Council, and I understand that the Council is prepared at any to pass a resolution requesting the authorities to make such appointment, in the interest of the Citizens of Vancouver, B.C.

The matter in so far as the City of Vancouver is concerned is a serious one, as we have absolutely no control over foor-stuffs, I am not permitted under the Dominion Act to examine, condemn or prosecute for adulteration of food-stuffs, this power being vested only with Analysts appointed by the Dominion Government, although for years, I have conducted examinations for different Departments of the Federal Service, all of which work has always been done willingly and without charge.

In requesting the appointment as Dominion Analyst, no salary or fees are asked or expected, I am willing to abide by any just regulations which may be imposed, I am also willing that the Chief Analyst in Ottawa should centrol all of my actions in so far as it affects the appointment as Dominion Analyst, and that no action will be taken as a result of such appointment until it has first received the sanction of the Chief Dominion Analyst.

I am merely requesting the privilege of properly performing my duties as Analyst for the Corporation of the City of Vancouver, with four Food Inspectors coverning the city daily, cases of adulteration come to our notine which demands immediate attention, but in these

cases we are helpless. We do condemn and destroy fock-stuffs on my certificate as City Analyst, but this is not legal, the situation is at times desperate and we simply must act, but our only reason for acting in this manner is for the purpose of affording in some measure a protection which the public has a right to expect, at any time our authority for action may be questioned, then of course we are at the mercy of the merchants concerned who have a right to question the fact that the analyses were not completed by a Dominion Analyst, in which case we leave ourselves open to legal action and damages.

I am absolutely at a loss to know why this appointment was not given to me long ago, there is no question as to my qualifications, twenty years as City Analyst and year after year appearing before every Court in the land undergoing cross-examination, with cases in the Police Court almost every day, having conducted analyses for years for different Departments of the Dominion Government, without charge, and view of Dominion Appointment requesting no salary or fees, willing to submit myself to all just regulations and to submit all Dominion matters to the Chief Analyst in Ottawa and be guided by his wishes, it seems only fair and just that the appointment should be immediately made, and thereby make legal all of the work allready done by this departmentand avoid any possibility of legal action against either the Corporation of the City of Vancouver or ourselves.

BUTTER PROSECUTIONS.

Although Mr. S.S.Taylor before Magistrate Shaw yesterday afternoon made a strenumus effort the have the "butter-watering" charges, laid several days ago against two wholesale firms dismissed, the charges are still pending in the Police Court.

0

The only evidence taken yesterday was given by City Analyst John F.C.B.Vance, and by Mr. R. H. Cook, clerk in Prichards grocery store the place where the sample of butter analyzed by Mr. Vance, was obtained, Mr.Vance briefly stated that he had examined the butter submitted to him by Dominion Food Inspector Clark, and had found over 22.per cent. of water.

Mr. S.S.Taylor, who appeared for the accused wholesalers, was not prepared to let it go at that, and he put the witness through a most rigid cross-examination, calling on him to explain each detail of the analysis, the precautions taken to secure accuracy, the means of testing the weighing scales, and every step in the whole transaction until the final figures indicating the amount of water were evolved.

Magistrate Shaw refused to dismiss the case. From the evidence submitted, he said it was quite apparent that there was some butter being sold in the city that contained about seven per cent more water then allowed by law. He stated that the matter certainly was one that deserved investigation, and suggested that samples of butter be taken at different stores and wholesale houses in the city, to see if the condition were general.

Mr. Taylor consented to this move, and all parties agreed on a committee consisting of Dominion Food Inspector Clark, Mr. A.P.Slade, and City Analyst J.F.C.B.Vance, to collect the samples. They will collect three samples of each brand of butter sold in the city, one in the wholesale house and the other two in different grecesy stores. Mr. Taylor insisted that after the samples had been analyzed by Mr. Vance, they should be sent to Victoria and analyzed again, so that there could be no possible doubt as to the exactness of the double independent analyses. This course was agreed upon.

The case was adjourned for a week but if all agreed upon can not be accomplished by that time, a further adjournment will be granted.
